

TERMS AND CONDITIONS



1. Invitation

The Netherlands Film Fund cordially invites you to participate in the inaugural edition of NLWave25, scheduled to take place in Utrecht from 24 to 26 September 2025. NLWave25 is an initiative of the Netherlands Film Fund in co-operation with SEE NL and EYE Film Museum.

This invitation is personal and is not automatically transferable. Invited guests unable to attend, are kindly requested to suggest the name of a colleague within their company or organization who is involved in acquisitions (if representing a sales agency) or programming (if representing a festival or institute).

Should an invited guest wish to be accompanied by a colleague (or partner), such requests may be accommodated upon payment of an accreditation fee. The additional person is also responsible for arranging, as well as paying, for their travel and accommodation. This policy equally applies to professionals whose travel and accommodation can't be covered this year due to budgetary limitations.

Please be advised that the availability of additional accreditations is limited and will be allocated on a first-come, first-served basis. All requests must be submitted no later than 31 August 2025.

2. Travel and Accommodation

A return journey is offered between the guest's place of residence (or nearby) and Utrecht, as well as two hotel nights and full catering during NLWave25.

Should a return journey on Friday evening prove infeasible - such as in the case of transatlantic trips - the organisation will provide an additional night's accommodation. Should a guest wish to extend the stay, for example to attend the Netherlands Film Festival*, commencing on 26 September, please indicate this on the form provided.

All travel must take place between 21 September and 3 October 2025.

*The organisers will notify the Netherlands Film Festival of a guest's interest in extending their stay. Whether a festival pass or additional hotel accommodation is offered will be at the festival's discretion. Alternatively, the guest will be responsible for arranging the extra nights independently.

Please note that once travel tickets are issued they cannot be modified. Should a guest choose to alter the travel itinerary, any additional costs incurred will be charged to the guest's credit card, details of which will be requested for this purpose.

If applicable, it is the responsibility of guests to obtain the necessary visas and comply with entry requirements for the Netherlands. The organisers are not liable for issues arising from non-compliance.

3. Sustainability Goals

In line with the commitment to sustainability, NLWave25 is committed to minimise environmental impact. The organisers therefore encourage guests to travel by train rather than by plane - wherever feasible.

The standard meals provided are vegetarian. Should a guest have any specific dietary requirements or food allergies, the organisers kindly request they are informed well in advance, so that they may accommodate special needs.

4. Accessibility and Safety

The event will include accessibility accommodations for guests with disabilities. Those requiring specific support are kindly requested to inform the organisers well in advance to facilitate the necessary arrangements.

The organisers cannot be held responsible for any personal injuries, property loss or damages incurred during the event. Guests are encouraged to take personal responsibility for their safety and belongings throughout their entire stay. The organisers do not provide travel or medical insurance coverage.

Guests are expected to adhere to a professional and respectful code of conduct during the event. The organisers reserve the right to remove anyone from the programme in cases of harassment, inappropriate behaviour or violations of the code of conduct.

Contact details for the organisers of NLWave25 and relevant local authorities will be provided for assistance in case of emergencies.

5. Modifications

The organisers reserve the right to modify NLWave25's programme schedule; participants will be informed of significant changes in a timely manner.

In the event of cancellations or modifications due to unforeseen circumstances such as natural disasters, political unrest or pandemics, the organisers will endeavour to inform guests promptly. However, the organisers cannot be held accountable for any resulting inconvenience or expense.

6. Privacy

Please be advised that photos and recordings may be taken during NLWave25 for promotional purposes. Guests who prefer not to be featured, kindly inform the organisers in advance.

Personal data collected for the event, such as names, contact information, birth dates, dietary preferences... will be stored and processed in compliance with the General Data Protection Regulation (GDPR). Data will be used solely for event organisation purposes and will not be shared with third parties without prior consent.

By accepting the invitation, and given the nature of NLWave25, guests allow the organisers to share essential information with confirmed attendees: their name, position, name of the organisation and contact email address, as provided through a designated form.

7. General

These terms and conditions are covered by the laws of the Netherlands. Any disputes arising from participation in the event shall fall under the exclusive jurisdiction of the courts in Amsterdam.
